



The transformation of Tidewater Gardens began the second week of December as preparations were made to demolish a six-unit building located at the corner of Fenchurch and Wood streets. Residents who lived in the building have been relocated to new housing of their choice with the help of People First.

The building demolition makes way for a new pump station that will support new homes in the St. Paul's Area. Construction on the new pump station will start at the beginning of the year. The pump station is necessary before construction can begin on the new multi-family and senior homes across the street. For more information on the pump station, see below.



# A TINY NEW BUILDING WILL HELP KEEP THINGS FLOWING IN ST. PAUL'S

You have heard of the new homes planned near the Downtown Transit Center as part of the St. Paul's Area Transformation. To keep things moving from the homes and businesses through the sanitary sewer system, a new pump station must be constructed across the street from the development.

In 2021, the City of Norfolk's Department of Utilities will construct a new sanitary sewer pump station located at 526 Fenchurch Street. The new pump station will move nearly 800,000 gallons a day of domestic and business wastewater to the Hampton Roads Sanitation District (HRSD) facilities for appropriate

"The collection and treatment of wastewater is vital to public health and clean waterways," said Gabriel Phelps, P.E., Utilities' Project Manager for the new pump station.

#### FREE LITTLE LIBRARIES

Did you know that every St. Paul's neighborhood has a Little Library? These libraries, made out of newspaper bins and painted by local artists, provide a convenient resource for reading and borrowing books directly in your neighborhood. The book inventories offer something for everyone and range from early reader to older adults. All of the Libraries have been placed on the national registry and were established through a partnership with Friends of Norfolk Public Libraries, the City, and NRHA. NRHA and People First-USI collaborated with local non-profits to ensure that reading materials are replenished regularly. NRHA is currently working with the Foodbank of Southeastern Virginia to open a Food Hub in the Young Terrace Community Center located at 804 Whitaker Lane. The Food Hub will provide weekly food distributions by appointment to ensure social distancing measures can be maintained and to avoid long lines. Residents will have

the opportunity to order the dry products they would like ahead of time, schedule a time to pick them up and also have the ability to shop for produce, protein and additional items on site at that time. After a soft launch in December, the Foodbank plans to increase days of operation/hours based on the demand and expressed needs of the community. The Foodbank will also partner with providers to bring services that address the root causes of food insecurity on site at the Food Hub at the same time as food distribution. 
### NRHA FAMILY SELF-SUFFICIENCY PROGRAM
