### **ASPIRE AT CHURCH STREET**



The newest apartment home community in the St. Paul's area of Norfolk is called Aspire at Church Street - 85 affordable apartments now available for leasing. There are 21 apartment homes reserved for former Tidewater Gardens residents interested in living in this new development.

Located at the intersection of Church Street and Brambleton Avenue, Aspire offers affordable one to three-bedroom apartments with both indoor and outdoor amenities designed to elevate daily living. Outdoor amenities include a spacious club house with a demonstration kitchen, along with an on-sight laundry facility and business center; inside each apartment home is a modern kitchen with LED lighting, vinyl plank flooring, elegant bathrooms and more. ## **INCLUSIONARY OUTREACH**

The City of Norfolk continues its commitment to economic inclusion of minority and women-owned businesses in the transformation of St. Paul's. In the months of July and

August, contracting opportunities within the former Tidewater Gardens neighborhood were presented to 158 contractors as part of two MWBE Vendor Fairs, held in July at The Basilica of Saint Mary of the Immaculate Conception, and at the Murray Center in August.



These vendor fairs are a unique opportunity for minority, women-owned, and small businesses to connect with the Tidewater Gardens Redevelopment project and explore potential subcontracting and partnership opportunities.

Developers from Brinshore Development, Breeden, Harkens and the Oughtness Group did a deep dive into the various



contracts available and took questions from participants. Those in attendance were also able to have some one-on-one time with vendors including the Virginia Dept.

of Small Businesses and Supplier Diversity (SBSD); Norfolk Dept. of Housing and Community Development (DHCD); City of Norfolk Office of Diversity, Equity and Inclusion; Norfolk Redevelopment and Housing Authority (NRHA), Carolinas-Virginia Minority Supplier Development Council, and Associated Builders & Contractors VA. while noshing on refreshments provided by **Options Eatery**, a local SWaMcertified business.
