the Norfolk Public Schools Board, and made history as the youngest appointed and first African American Director for the Norfolk Division of the Hampton Roads Chamber of Commerce. He holds a Bachelor of Science Degree in Training with a Minor in Leadership from Old Dominion University and is currently completing a Master of Public Administration (MPA).

Paige and Clanton will continue to lead the group of 22 Norfolk residents selected to represent a full range of community voices and stakeholders in the transformation of St. Paul's. Clanton says he's excited about this new challenge, and shares, "Leadership is not about a title or position; it's about listening, serving, and empowering others to reach their full potential."
